BIS Bulletin: Oct-Nov 2025

This edition captures key updates from the Bureau of Indian Standards (BIS) focused on Quality Control Orders (QCO)/ Compulsory Registration Order (CRO) for October and November 2025.

- Re-calibration of QCO policy:
- A. NITI Aayog report The High-level committee for Non-Financial Regulatory Reforms at NITI Aayog in its report suggested 7 reforms in relation to QCOs:
 - Revoke 8 QCOs on synthetic fibres, yarns and inputs
 - ii. Revoke 7 QCOs on plastics and polymers
 - iii. Revoke 7 QCOs on base metals
 - iv. Suspend implementation of QCOs in certain categories of steel products (112 products across 6 categories)
 - v. Revoke SIMS and No-objection Certificate (NOC) process for import of non-QCO steel grades
 - vi. Revoke 5 QCOs of footwear and electric components
 - vii. Defer implementation and refer to Inter-Minesterial Group for all upcoming QCOs issued by all line ministry on raw materials, intermediate goods and finished goods
- **B. Execution by Government –** As of November 30, 2025, following actions have been undertaken:

II. Suspension of QCO:

- The Machinery and Electrical Equipment Safety (Omnibus Technical Regulation) Order, 2024 ('OTR') which was slated for implementation from 1 September 2026, now stands deferred indefinitely.
- ii. The upcoming phased implementation of products covered under Electrical Equipment (Quality Control) Order 2020 has been deferred till issue of further orders

III. Actions relating to Steel and Steel Products QCO:

- Mapping steel grades across all HS Codes not covered under Steel QCO on SIMS portal. No clarification or NOC would be required for such steel grades
- ii. Suspension of 42 Standards for a period of three years covering steel grades predominantly used in the manufacturing of engineered products, automotive and durable goods
- iii. Suspension of 13 Standards for a period of one years covering specialty steel grades majorly used in niche and high-precision applications, including materials requiring exceptional strength, hardness, dimensional accuracy and thermal stability.

QCOs implemented in October and November 2025:

The following QCOs have been implemented in October 2025 and November 2025 (except for small and micro enterprises):

- Grant of All India First license for products covered under new QCOs: BIS has granted All India First license for following product categories:
 - i. IS 17632: 2022: General purpose chairs and stools covered under Furniture (Quality Control) Order, 2025
 - ii. IS 16819: 2018: Safety of Machinery General Principles for Design - Risk Assessment and Risk Reduction for Injection Moulding Machine covered under Machinery & Electrical Equipment Safety (Omnibus Technical Regulations), 2024

(Note- The 'All India First License' refers to BIS granting a company the very first certification for a specific product under a new or updated IS)

- Update on Steel and Steel products QCO:
- A. Exemption to additional steel grades meant for use in various strategic sectors: MoS has issued Orders dated October 6, October 7, and October 15, 2025, granting a six-month exemption from the NOC process for 15 additional steel grades intended for use in the following strategic sectors:
 - Automotive
 - Power generation and distribution

- Automobiles & components
- Mining
- Textile
- Tool and die
- Oil and gas
- Construction
- Hand tools

The above is in furtherance to Order dated September 27, 2025, which granted similar exemption to 52 steel grades.

The SIMS 2.0 portal has been parallelly updated to accommodate NOC filing process for such steel grades.

- B. Exemption on input steel used for manufacture of final products: An exemption has been granted vide Order dated October 6, 2025, on mandatory input adherence for following Standards of stainless-steel flat products till March 31, 2026:
 - i. IS 6911:2017 Stainless-steel plate, sheet and strip - Specification
 - ii. IS 5522:2014 Stainless-steel sheets and strips for utensils Specification
 - iii. IS 15997: 2012 Low nickel austenitic stainless-steel plate, sheet, and strip for utensils and kitchen appliances -Specification

The above exemptions have been granted due to insufficiency in domestic production capacity.

C. Exemption to listed HS Codes under Steel QCO: MoS vide its Order dated October 6 and November 20, 2025, has provided a list of HS Codes for 16 Indian Standards which are exempted from mandatory application of various QCOs notified for such products. Refer Annexure 1 for the QCO-IS-HS Code mapped list for reference.

It has been further clarified that exemption from mandatory requirement of adherence to QCO is also applicable on imports of above products with Bill of lading having shipped on board date on or before March 31, 2026.
